Notice of Availability of Draft MSR/SOI and Public Hearing**

NOTICE IS HEREBY GIVEN that on **Thursday, July 23, 2026, at 9:00 a.m.**, or as soon thereafter as the matter may be heard, the Yolo Local Agency Formation Commission (LAFCo) will hold a public hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider adoption of a:

**COMBINED SURFACE WATER AND GROUNDWATER SERVICES
MUNICIPAL SERVICE REVIEW (MSR) AND SPHERE OF INFLUENCE
STUDY(SOI) (LAFCO NO. 25-05)**

The intent of the MSR is to review services provided by the following agencies: Dunnigan Water District, Yolo County Flood Control & Water Conservation District, and Yolo Subbasin Groundwater Agency. The MSR makes recommendations regarding agency improvements. The Commission will receive an overview of the draft MSR and will consider recommendations for MSR determinations for each district or agency. Staff has reviewed the Spheres of Influence (SOIs) of each agency and recommends that no update to the existing Spheres of Influence is necessary at this time.

The Draft MSR/SOI Study, agenda, and staff report will be available for public review online at www.yololafco.org. Written comments on the MSR/SOI Update can be submitted to the LAFCo office either by mail at the address stated below or via email to LAFCo Deputy Executive Officer JD Trebec at lafco@yolocounty.gov. Copies of the agenda, staff report, and supporting information will also be available and may be examined at the LAFCo office, located in the Yolo County Administrative Building, 625 Court Street, Suite 107, Woodland, CA, and online at www.yololafco.org at least five days prior to the noticed hearing date. Any affected agency or interested person may also appear and present oral or written testimony at the hearing.
