**Yolo Local Agency Formation Commission
Notice of Public Hearing**

Notice is hereby given that on **Thursday July 26, 2018 at 9:00 am**, or as soon thereafter as the matter may be heard, the Yolo Local Agency Formation Commission (LAFCo) will hold a Public Hearing at the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, CA to consider the following agenda item:

Project Title:

Dissolution of Reclamation Districts 2076 and 2120 (LAFCo No. 923)

Project Description:

Government Code Section 56879 is a new law which requires LAFCo to initiate dissolution of inactive districts by resolution within 90 days of receiving notification from the Controller that a district is inactive, and is required to dissolve inactive districts after one public hearing. On May 24, 2018 LAFCo approved Resolution of Application 2018-03 initiating proceedings to dissolve Reclamation Districts 2076 and 2120. Reclamation District 2076 has been inactive since it was formed in 1928, and has never provided services since its inception. Reclamation District 2120, formed in 1983, was sold in 1999 to the US Army Corps of Engineers for habitat mitigation purposes and has been inactive since.

Location:

RD 2076 is located completely within the southern part of the Yolo Bypass. Its northern boundary begins parallel with County Road 36 with the western and southern boundaries at the Yolo/Solano line. The eastern boundary is the Sacramento River Deep Water Channel.

RD 2120, known as Little Holland Tract, is generally located in southern Yolo County, adjacent on the eastern boundary to the Sacramento River Deep Water Channel, and on the west to the Liberty Cut. Approximately, the southern third of the area is in Solano County.

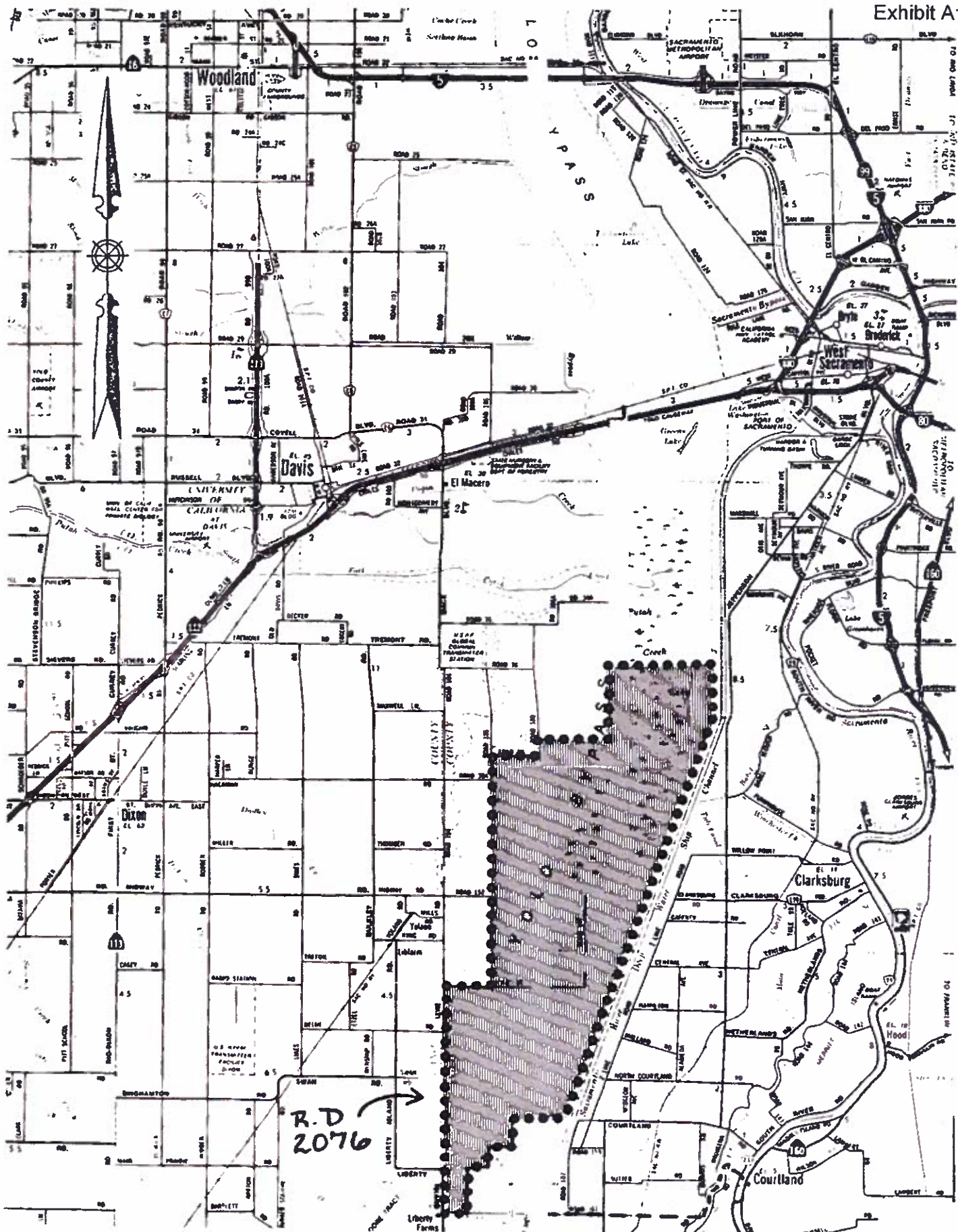

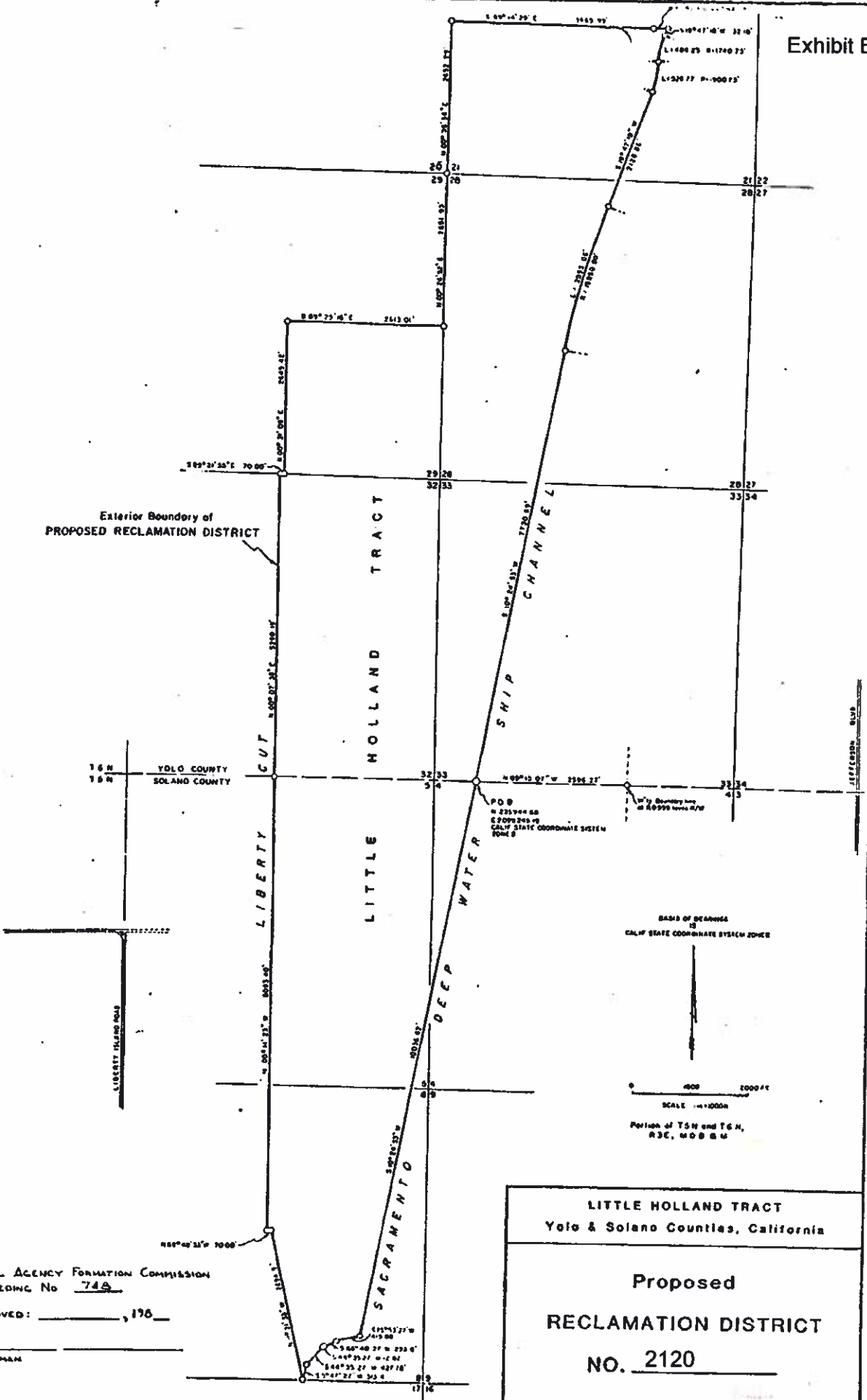
