2022 GOVERNANCE RECOMMENDATIONS OVERVIEW

Overall Strategy/Approach
 The scope of this discussion is framed by the following determinations required for each MSR (collectively referred to as "governance" recommendations):


- **Shared Services and Facilities:** "Status of, and opportunities for, shared services and facilities"
- **Accountability, Structure and Efficiencies:** "Accountability for community service needs, including governmental structure and operational efficiencies"

Given the adequacy, deficiencies, and needs of fire services provided by each FPD, the MSR Subcommittee met five times in January 2022 to develop draft governance recommendations. The MSR Subcommittee was guided by the following values and principles:

- What promotes the best service to the public?
- What is the most efficient and effective utilization of our resources?
- What is the "right" balance of economies of scale versus flexibility to address local conditions?

Below is an explanation of the overall approach and strategy. Individual recommendations for each FPD to implement this strategy are included in each individual section of this MSR/SOI as applicable. The 15 FPDs are separated into Areas 1-5 with recommendations for each. The base map shows a heat map representing calls for service, a data visualization technique that shows the magnitude and spatial distribution of calls for service. Below this map a narrative follows that explains what is recommended for each of Areas 1-5 shown.

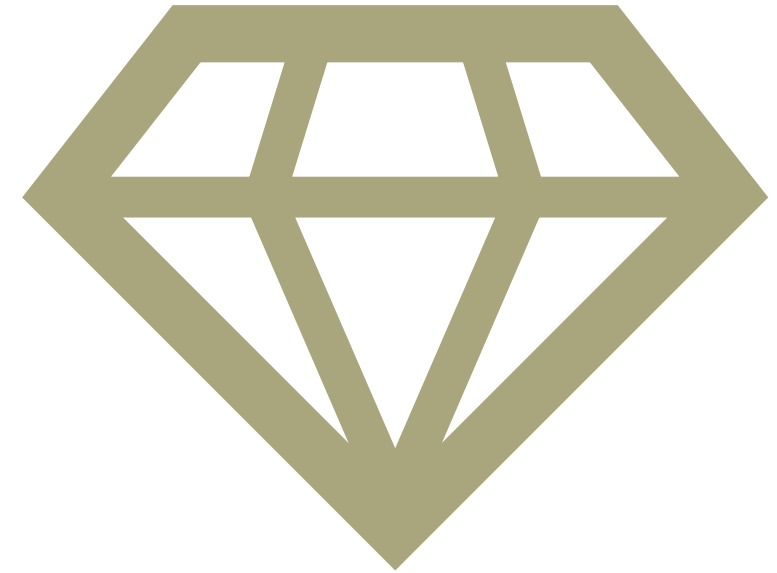



The Value of Service Reviews

Why are they so valuable?

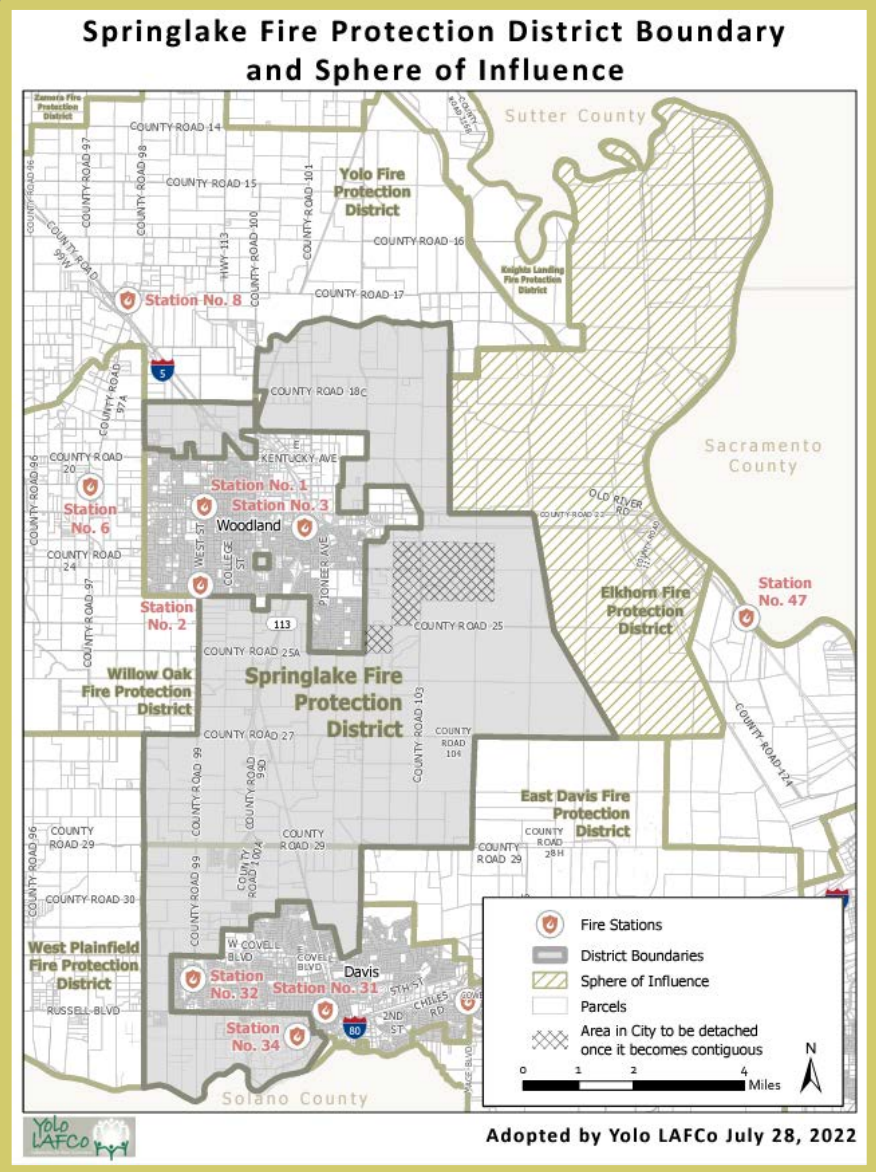
Who uses them outside of our region?

The Value of a Sphere of Influence (SOI)

- SOIs illustrate how MSR recommendations should be implemented
- It “points the way” for future changes of organization
- It’s a necessary 1st step to allow future annexations



LAFCo Actions

Change of Organization / Reorganization

(one or more of these):

- Annexations and detachments
- City incorporation and disincorporation
- District formations and dissolutions
- Consolidations, mergers, subsidiary district
- Service extensions outside a District or City
- Activate latent powers and divest of powers



Each Commission is Independent

- Commission is sole authority over budget
- Sole authority over office, equipment, personnel
- Appoints an Executive Officer
- Appoints a Legal Counsel
- May contract for staff services

When Does LAFCo Get Involved?

- LAFCos vary in approach (proactive vs. reactive)
- Opportunities:
 - Planning level (e.g., General Plans)
 - City/County Project level (e.g., application comments + CEQA)
 - LAFCo pre-application and application
 - Community issues



What Makes Yolo LAFCo



So Unique?

- Very proactive
- Great example of LAFCo as a resource
- Leader in ag/open space preservation
- Facilitate shared services conversations - building a collaborative culture in the region
 - YED Talks
 - Website transparency scorecards
 - JPA service reviews
 - Yolo broadband strategic plan
- Institutional knowledge and expertise combined with new perspectives

Informed Decision Making

- For most of you, LAFCo is a secondary position...**BUT**...that should not justify less attention or care to LAFCo decisions.
- It is your responsibility to be prepared for the meeting so you can make well informed decisions.



Accountability

- Commissioners make final decisions
- Decisions cannot be appealed to other administrative bodies
- Actions accountable to the public via the protest process
- LAFCo staff accountable to Commission and statutes
- Adopt local policies and procedures

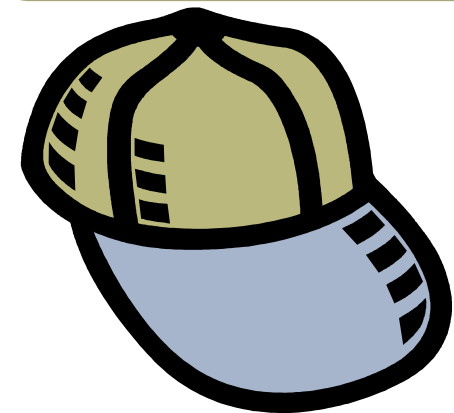
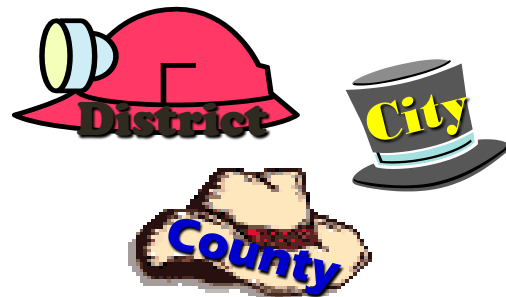


Commissioner Decision Making
