# <u>Item № 10</u> <u>Executive Officer's Report</u>

The Commission was given written reports of the Executive Officer's activities for the period of April 22, 2019 through May 17, 2019, and was verbally updated on recent events relevant to the Commission.

Staff updated the Commission on an upcoming change in the way CALAFCO member dues are calculated, which will be voted on by the Association membership in October 2019. It includes changing the formula from rural, suburban and urban categories to a population-based method with base dues and a cap at 700,000 in population. Dues would continue to increase thereafter with Department of Finance projections and the CPI (Consumer-priced index). Staff asked the Commission if it would like to schedule an item for future discussion and the Commission indicated it was not necessary.

Staff commented on the Long Range Meeting Calendar noting the West Sacramento Basin Reclamation District Reorganization proposals, which includes the City's proposal and RD 900s proposal, was moved to the July meeting at the request of the District and the City due scheduling conflicts. Also, staff is awaiting requested financial information from the City and RD 537.

## **Item № 11** Commissioner Reports

Chair Woods stated that he enjoyed attending the 2019 Planning Commissioner Training Workshop, recommended by staff and hosted by the Sacramento Valley Section of the American Planning Association. The Workshop covered best practices for running a meeting, the General Plan and Housing Element, Specific Plans & zoning implementation, and CEQA basics. Chair Wood commented that, although he could not stay for the whole Workshop, the session was outstanding and he would like to catch up on what he missed at a future session.

Subject: Support of AB 818

Dear Assembly Member Cooley:

The Yolo Local Agency Formation Commission (LAFCo) is pleased to support **Assembly Bill AB 818**, which would assist the fiscal viability of future city incorporations that meet all other state requirements.

The VLF gap created by SB 89, one of the 2011 budget bills, created a financial disincentive for future city incorporations and annexations of inhabited territory. For the past seven years, no new cities have formed. Given the growing population in our state and the need for orderly growth and adequate service provision, this policy issue needs to be addressed.

**AB 818** by no means guarantees that a community wishing to incorporate will become a city. In order to incorporate, local communities have to overcome many hurdles, including compliance with state LAFCo policies, negotiations with counties, and ultimately a public vote. This bill simply gives communities considering incorporation the same opportunity to incorporate that other California cities have previously had.

In 2017, the Legislature addressed the financial harm caused by SB 89 (2011) to four recently incorporated cities via the passage of SB 130 (Budget). SB 130 provides the legislature a template to address the fiscal viability of future incorporation. *AB 818* adopts the template provided by SB 130 and extends the fix to future incorporations. The state budget conditions have vastly improved since 2011 and the fiscal challenges of the four most recently incorporated cities have finally been addressed with the passage of SB 130. *AB 818* provides the same option for any future incorporations.

Reinstating revenues for incorporations is consistent with policies of providing communities with local governance and efficient service delivery options, including the ability to incorporate. The inability to do so creates a tremendous detriment to the creation of logical development boundaries and to the prevention of urban sprawl. Because **AB 818** reinstates a critical funding component to future cities incorporating, Yolo LAFCo supports this bill.

# Supreme Court Allows Prop. 218 Challenge Without Participation in Protest Hearing in Narrow Ruling

**Introduction.** On May 31, the California Supreme Court decided Plantier v. Ramona Municipal Water District. The case had been expected to resolve whether a challenger to a property related fee or charge under Proposition 218 must participate in the majority protest hearing to sue or, at least, limit claims in court to those raised at the hearing. Instead, the Court decided the case

very narrowly, leaving that issue to be decided in another case, perhaps Marin Municipal Water District v. Walker (Marin), a recent, unpublished decision of the San Francisco Court of Appeal. A petition for Supreme Court review of Marin must be

granted or rejected in June or July.

**The Decision.** The Ramona Municipal Water District provides water and sewer services. Unlike many such dual-utility agencies, it does not collect sewer charges on water bills, but on the property tax roll. Accordingly, sewer fees are fixed annual amounts based on the size and use of property expressed in "equivalent dwelling units" or EDUs. The District adjusted a restaurant's EDU assignment from 2.0 to 6.82, concluding the original figure was mistaken. The restaurateur challenged the

reassignment, arguing that Proposition 218's mandate that fees be proportionate to service cost requires sewer rates to be based on the volume of water used. He later sued, along with two commercial property owners, as representatives of a class of all customers.

The District argued the plaintiffs did not exhaust their administrative remedies by participating in the protest hearing on sewer

> rate increases proposed at about the same time as his EDU assignment. The trial court accepted the exhaustion of remedies defense, dismissing the case.

Mr. Plantier disputed certified the class, but

The San Diego Court of Appeal reversed, in a very broad and troubling opinion, concluding exhaustion is never required in a Proposition 218 case. The Supreme Court granted review — leading to the new, and much narrower, decision.

The Supreme Court reasoned that, even if one must participate in a Proposition 218 majority protest hearing before bringing **some** challenges (which it assumed without deciding), a challenge to Ramona's EDU methodology was not among them. This was because the District gave notice of hearings

on proposed rate increases, not on a change to its rate structure — i.e., the EDU formula. As the District could not have acted on Mr. Plantier's complaint at its hearing except by making a new rate proposal that did change the EDU formula, which would require a new hearing, its majority protest hearing was not a fit forum to resolve it.

The trial court cited Wallich's Ranch Co. v. Kern County Citrus Pest Control Dist. (2001), which many public lawyers read to require exhaustion in Proposition 218 cases. The Supreme Court read that case to require exhaustion under the Citrus Pest District Control Law, not Proposition 218. Thus, with Wallich's Ranch found off-point and the Court of Appeal opinion in this case largely displaced by the Supreme Court decision which does not decide whether one must participate in a majority protest hearing under Proposition 218 — this question is now plainly open. Perhaps the Marin case will resolve it. Along the way the Court made these helpful points:

- The Proposition 218 Omnibus Implementation Act of 1997 is good law to construe the measure. *Greene v. Marin County Flood Control & Water Conservation Dist.* (2010) held this previously, but it is nice to have a current restatement of the rule.
  - Rate-making is legislative activity, a question the Court of Appeal here had thought unclear and, by stating so in a published decision, made it so.
  - The provision of the Omnibus Act allowing inflation adjustment of

triggering a new protest hearing is property related fees without good law. Although this language is technically "dicta," rather than a holding, it is helpful nonetheless.

**Options for Rate-Makers.** In light of this decision, public agencies which make rates subject to Proposition 218 should consider:

- Adopting a local procedure for resolving complaints about legislative decisions to adopt rates and ratemaking formulas (like the EDU system here) as well as administrative decisions to assign a property or ratepayer to a rate class. A plainly applicable local procedure must be exhausted whether or not participation in the Proposition 218 majority protest hearing is required. Indeed, Ramona has such a procedure and Mr. Plantier was obliged to exhaust it.
- Writing notices of majority protest hearings broadly to invite protests on rates, rate-making formulas and, perhaps, customer classification issues, so that its clearer than in *Plantier* than the Board or Council can address potential plaintiffs' claims.

**Conclusion.** The question that *Plantier* left open will eventually be decided.

# RE: Request to Sign AB 1822 Assembly Local Government Committee Omnibus Bill

Dear Governor Newsom:

The Yolo Local Agency Formation Commission (LAFCo) respectfully requests that you **sign Assembly Bill 1822** (Assembly Local Government Committee) which is now before you for action. **AB 1822** makes changes and clarifications to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.

This annual bill includes technical changes to the Act which governs the work of local agency formation commissions. These changes are necessary as commissions implement the Act and small inconsistencies are found or clarifications are needed to make the law as unambiguous as possible. **AB 1822** makes several minor technical changes, corrects obsolete and incorrect code references, and makes minor updates to outdated sections. Without making any policy changes, the revised language greatly clarifies the laws and eliminates outdated and confusing language thereby creating a significant increase in the clarity of the Act for all stakeholders.

Because this legislation helps insure that the Cortese-Knox-Hertzberg Act remains a vital and practical law that is consistently applied around the state, and clearer to all who use the Act, we respectfully urge you to sign **AB 1822**.

- 1. Open the Public Hearing, ask staff to summarize Resolution 2019-08 and provide an opportunity for comments including oral or written protests.
- 2. If greater than 25% landowner protest is received (i.e. 5 or more landowners), take a quick break for staff to calculate the total assessed value of land owned by those landowners who have submitted protest.
- 3. If less than 25% landowner protest is received (i.e. 0 4 landowners) that combined own less than 25% of the assessed value of land within the affected territory (i.e. less than \$6,014,044), adopt Resolution 2019-08 ordering the Reorganization of the Lower Elkhorn Reclamation Districts, subject to term and conditions.

## FISCAL IMPACT

No fiscal impact to LAFCo. The RDs as the proposal applicants are required to reimburse Yolo LAFCo for all processing costs.

Regarding fiscal impact to the RDs, the reorganization will not become effective until following the successful passage of a Proposition 218 election to establish a new assessment structure for the combined reclamation district territory. In addition, RD 537 would become the successor district receiving RD 827's current portion of the 1% property tax revenues.

# REASONS FOR RECOMMENDED ACTION

LAFCo approved this proposal on May 23, 2019. Government Code §57000 et. seq. requires a protest hearing after the Commission approves agency reorganization without 100% consent from the landowners. The Yolo LAFCo is the conducting authority for the protest process as specified by Government Code Section 57050(b). This hearing allows landowners to file official protests to the reorganization if they so desire. All three RD boards (RD 537, RD 785 and RD 827) submitted the proposal for reorganization.

## BACKGROUND

RD 537, RD 785 and RD 827 jointly initiated an application to dissolve RD 785 and RD 827 and annex both RD territories into RD 537. LAFCo approved this proposal on May 23, 2019. This proposal effectively combines the three RDs into one to more efficiently maintain the Lower Elkhorn Basin levee system, including the proposed DWR Lower Elkhorn Basin Levee Setback project.

The hearing for this proposal has been properly noticed, posted, and published as required by the Cortese-Knox-Hertzberg Act. Notice of this protest hearing has been provided to subject and affected agencies, the 18 landowners, all registered voters within the affected territory (i.e. RD 785 and RD 827), plus a 300' radius area. After the hearing is closed, the Commission should determine the number of all valid oral and written protests received.

Because the RDs involved are "landowner-voter districts", protest is measured based on percentages of both the 18 total landowners and total assessed value of \$24,056,176. If protest is filed by less than 25% of the number of landowners owning less than 25% of the assessed value of land, the Commission shall order the dissolution/annexation. If between 25% - 50% of the landowner/value file protests, the Commission shall order the dissolution/annexation subject to an election. Over 50% protest automatically terminates the proposal.

No written protests have yet been received by LAFCo as of June 18, 2019.

Conducting Authority Resolution Ordering the Reorganization of the Lower Elkhorn Reclamation Districts (RDs), Dissolving RD 785 and RD 827 and Annexing Both Districts' Territories into RD 537 Without an Election, Subject to Terms and Conditions (LAFCo № 928)

**WHEREAS**, on December 10, 2018, Reclamation District (RD) 537, RD 785, and RD 827 (the Lower Elkhorn Reclamation Districts) jointly submitted the subject proposal application (LAFCo № 928) to the Yolo Local Agency Formation Commission (LAFCo or Commission) accompanied by a Resolution of Application from each of the three RDs; and

**WHEREAS,** the proposal was routed to all subject, affected, and interested agencies and no concerns or objections were received; and

WHEREAS, the proposal is subject to a negotiated exchange per Revenue and Taxation Code Section 99(b)(1), and the Yolo County Board of Supervisors adopted a resolution determining an exchange in property tax revenue between RD 827 and RD 537 on April 23, 2019; and

WHEREAS, a Certificate of Filing was issued on April 25, 2019; and

**WHEREAS**, a public notice was published in the West Sacramento News-Ledger and mailed to all landowners and registered voters of the subject territory including a 300' radius; and

**WHEREAS**, the proposal was analyzed in accordance with all applicable sections of the Cortese-Knox-Hertzberg Act, LAFCo Standards of Evaluation and Agricultural Policy, and all other matters presented as prescribed by law; and

**WHEREAS**, on May 23, 2019, the Commission reviewed and considered the CEQA documentation and the staff report including all the information, recommendations, findings, and conditions contained therein: and

**WHEREAS,** on May 23, 2019, the Commission adopted Resolution 2019-06 approving the Reorganization of the Lower Elkhorn Reclamation Districts, dissolving RD 785 and RD 827, and concurrently annexing both districts' territories into RD 537 (LAFCo № 928) and set June 27, 2019, as the hearing date to conduct protest proceedings; and

**WHEREAS**, Government Code §57000 et seq. designates the Commission as the Conducting Authority for protest proceedings; and

**WHEREAS**, a notice of the Conducting Authority Hearing was published in the West Sacramento News-Ledger on June 5, 2019, and mailed to all registered voters and landowners both within the affected territory plus a 300' radius; and

**WHEREAS,** on June 27, 2019, the Commission opened the Public Hearing, staff summarized LAFCo Resolution 2019-08, and the Commission opened a Public Hearing to all interested persons, organizations, and agencies to present oral or written protests, objections, and any other information concerning the proposal and all related matters; and

**WHEREAS**, following the close of the Public Hearing, the Commission determined the value of all valid written protests filed and not withdrawn.

**NOW, THEREFORE, BE IT RESOLVED** that the Yolo Local Agency Formation Commission acting as the Conducting Authority for these proceedings orders the Reorganization of the Lower Elkhorn Reclamation Districts, dissolving RD 785 and RD 827 and concurrently annexing both districts' territories into RD 537 (LAFCo № 928) as illustrated in Exhibit A subject to the following findings and terms and conditions:

# **Conditions of Approval**

- 1. The applicant and the real party of interest, if different, agree to defend, indemnify, hold harmless and release the Yolo Local Agency Formation Commission, its agents, officers, attorney and employees from any claim, action or proceeding brought against any of them, the purpose of which to attack, set aside, void, or annul the approval of this application or adoption of the environmental review which accompanies it. This indemnification obligation shall include, but not be limited to, damages, costs, expenses, attorney fees, or expert witness fees that may be asserted by any person or entity, including the applicant, arising out of or in connection with the approval of this application, whether or not there is concurrent passive negligence of the part of the Yolo Local Agency Formation Commission its agents, officers, attorney or employees.
- 2. The reorganization will be subject to all appropriate LAFCo, State Board of Equalization, and County Clerk-Recorder fees prior to recording the Certificate of Completion for the Reorganization of the Lower Elkhorn Reclamation Districts (LAFCo № 928).
- 3. The reorganization shall not become effective until following the successful passage of a Proposition 218 election to establish a new assessment structure for the combined reclamation district territory.
- 4. A new boundary description for the new Reclamation District 537 boundaries reorganized under this proposal shall be prepared and submitted to LAFCo for recordation and filing with the State Board of Equalization.
- 5. Once all of the terms and conditions have been satisfied/completed, the Executive Officer shall prepare a Certificate of Completion to be recorded with the county recorder that confirms the final successful completion of the reorganization. The effective date of the reorganization shall be the July 1 following the filing of the Statement of Boundary Change with the State Board of Equalization (BOE) (i.e. after the Statement of Boundary Change is filed with the BOE, which is due by December 1 each year, the reorganization shall become effective July 1 of the following year).


