What a Municipal Service Review (MSR) and Sphere of Influence (SOI) Update Is

- The MSR is an <u>informational study</u> that makes <u>recommendations</u>
 - Recommends local government course of action
 - To be considered by the agencies studied
- The SOI is a planning area that shows recommended <u>future</u> local government boundary changes
 - Actual boundary change requires a subsequent process

Fire Protection Agencies (15 FPDs + 1 CSA) MSR Study Findings Generally

- Some FPDs with high community volunteerism are still successful with a volunteer model
- As societal change affects volunteerism, other FPDs have shifted (or need to shift) to city contract or paid staff model
 - Staff needed depends on call volume
 - Not all FPDs have sufficient revenue to cover these increased contract or staff costs (so responding personnel numbers can suffer)



FPD Financial Sustainability

- FPDs are all operating "in the black" (except No Man's Land)
- Where financial issues show up:
 - Low personnel response averages (not sufficient \$ to pay for staff or reserves if needed)
 - Low/declining fund balance
 - Making ends meet with CAL FIRE strike team revenue, and/or
 - Deferred apparatus replacement and/or maintenance
- FPDs that provide direct services are generally not able to fully fund a CIP
 - Supply chain issues and inflation have made costs even more volatile and difficult for FPD financial sustainability

Contract FPD Findings

- Yolo County is the ultimate governing body for the existing contract districts and will consider LAFCo recommendations
- Local Fire Commissions serve "at the pleasure of the Board of Supervisors"
- District boundaries haven't kept up with the evolution in service providers
- Fire Commission operation and contract terms vary widely



"Big Picture" MSR Recommendations

- Dissolve 2 FPDs: Elkhorn and No Man's Land
- Reorganize 6 districts into 4 (Area 4), one contract district for each city service area
- JOAs for remaining FPDs that provide direct services:
 - Area 1: Capay Valley, Esparto, Madison
 - Area 2: Dunnigan, Knights Landing, Yolo, Zamora
 - Area 3: West Plainfield, Willow Oak
- Area 5: Clarksburg (no JOA needed)

Joint Operation Agreements (JOAs) Areas 1-3 Considered a "Functional Consolidation"

- FPDs that provide direct services can band together through JOAs as a "functional consolidation"
- This means (for operational and practical purposes) FPDs are working together as one cohesive unit for greater efficiency and resiliency



- Madison FPD requested changes to JOA - still being negotiated



<u>Status</u>

- All 4 FPDs signed a JOA May 2021
- Dunnigan FPD hired new Acting Chief that is getting on top of issues
- Area 2 FPDs have lower core revenue and few paid staff (considering high call volume) compared to Areas 1 & 3
- Significant portions of Dunnigan and Knights Landing are disadvantaged





<u>Status</u>

Approach: Dissolve Elkhorn and NML FPDs - Reorganize districts to create 1 district for each city service territory

- Elkhorn FPD opposed to dissolution and suggests instead detaching I-5 and Old River Road calls (keeping FPD for fire calls only)
- East Davis FPD opposed to annexing other FPD territory also served by City of Davis
- Cities of Woodland and West Sacramento have urged LAFCo to resolve the Elkhorn FPD auto aid situation

According to YECA, Elkhorn FPD has missed a significant % of its own calls:


- 06.7% in FY 20/21

Area 4 Reorganization to Absorb Elkhorn FPD

Recommendation:

- Springlake FPD would annex 22k acres of Elkhorn FPD
- Springlake FPD already has 3 different service providers and 2 separate dispatch agencies
- City of Davis serves 3 FPDs
- Boundaries have not kept up (and should evolve to align with) service providers
- Reorganization would NOT immediately change existing contracts or assessments (administered by successor agency as applicable)
- East Davis FPD would NOT be subsidizing other new areas
- County would make contracts and assessments more consistent over time



- Streamline and standardize FPD-city contracts
